The team of Board-Certified music therapists MT-BC improves the lives of service members, veterans, medically fragile children, isolated older adults, and others year-round in San Diego. Most of Resounding Joy's clients will feel the effects of their diagnosis throughout their lives, whether it is depression, PTSD, a brain injury, Down Syndrome, congenital heart disease, or a rare disease. Individual and group sessions are offered throughout San Diego, primarily on-site at partner nonprofits.
