The team of Board-Certified music therapists MT-BC improves the lives of service members, veterans, medically fragile children, isolated older adults, and others year-round in San Diego and in Indiana, starting in late 2021.. Most of Resounding Joy's clients will feel the effects of their diagnosis throughout their lives, whether it is depression, PTSD, a brain injury, Down Syndrome, congenital heart disease, or a rare disease. Individual and group sessions are offered throughout San Diego, primarily on-site at partner nonprofits.
