We provide a continuum of care, with music therapists working in clinics, hospitals, facilities, schools, out in the community, in collaboration with other social service organizations and in-home. We work throughout San Diego County in facilities, public spaces and homes, ranging from Oceanside to Chula Vista.

Duties and Responsibilities

- Facilitate clinical music therapy in group and individual sessions
- Work with variety of clients in multiple settings, which may include:
 - Military service members, veterans and first responders
 - Children with a medical or mental health diagnosis and/or developmental disabilities in a school, social service, hospital or home setting
 - Bedside work in hospital or hospice settings (all ages)
 - Seniors and older adults
 - At-risk and under-served community members and social service organizations.
- Document impact of music therapy on a regular and timely basis.
- Conduct special events such as drum circles, memorial services, community events and presentations
- Facilitate business growth through networking, customer relationship building and outreach events
- Attend and participate in meetings and fundraising events as requested.
- Exercise good judgment and confidentiality in dealing with staff, clients, and the community.
- Additional duties as assigned

Requirements

- Bachelor's degree in music therapy.
- Music therapy certification credential, MT-BC.
- Minimum of two years' experience as a music therapist preferable.

- Experience in medical and hospice placements is preferable.
- Skilled clinical musician, strong in voice and guitar, piano, and/or drumming.

- **Passion for Music Therapy:** Show enthusiasm for contributing to the music therapy field.
- **Team Player:** Be dependable, responsible, and work well within a team.
- **Advocacy Commitment:** Dedication to advocating for the profession of music therapy.

- **Tech Proficiency:** Be comfortable and familiar with Microsoft products.
- **Transportation:** Hold a valid driver's license and have access to insured and reliable transportation.

- **Versatile Passion:** Express an eagerness to work in diverse settings with a wide range of patients, including adults in hospice, military veterans, first responders and their families, pediatric patients in medical and hospice care, unhoused individuals, those dealing with mental health and wellness, individuals who have experienced complex traumas, underserved communities, and older adults within a patient-centered framework.
